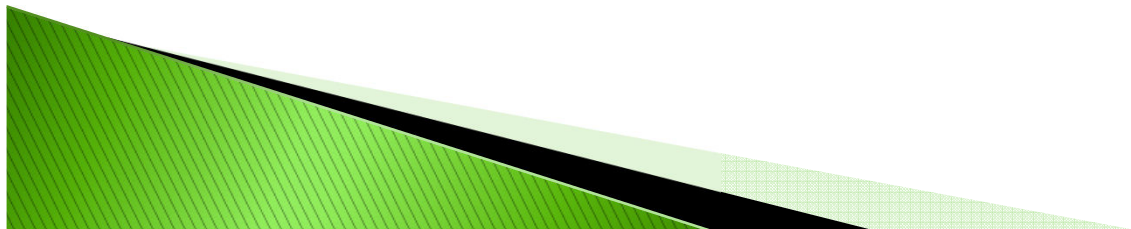
Which bodies

How to lobby?

- ▶ Bilateral interviews and talks
- ▶ Facilitation of CS participation in diverse fora
- ▶ Submissions to consultations/standart setting and inputs to negotiations
- ▶ Paralell reports
- ▶ Written and oral statements
- ▶ Lunch briefings & side events
- ▶ Communications to Special Procedures
- ▶ Civil Society Meetings – procesess



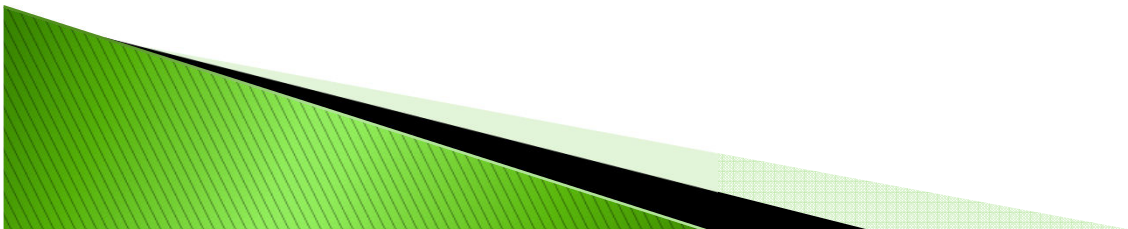
Treaty Bodies: CESCR, CEDAW, CRC

- ▶ Composition: Independent Experts
- ▶ Mandate: Interpretation of the covenants through General Recommendations or General Comments / Statements
- ▶ Monitoring implementation of States human rights obligations under a specific treaty: Concluding Observations – Standard setting
- ▶ Communications Procedures: Complaint mechanisms for individuals

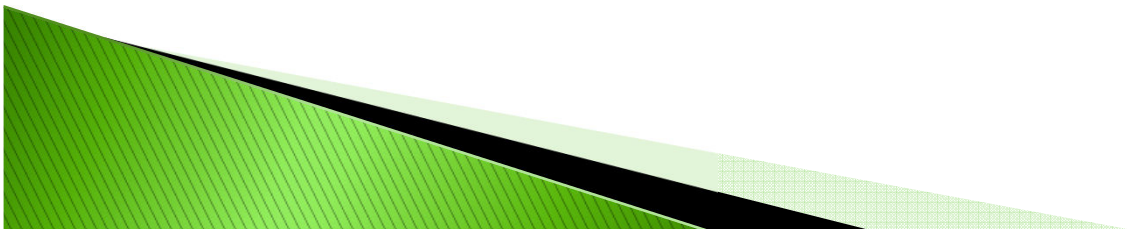

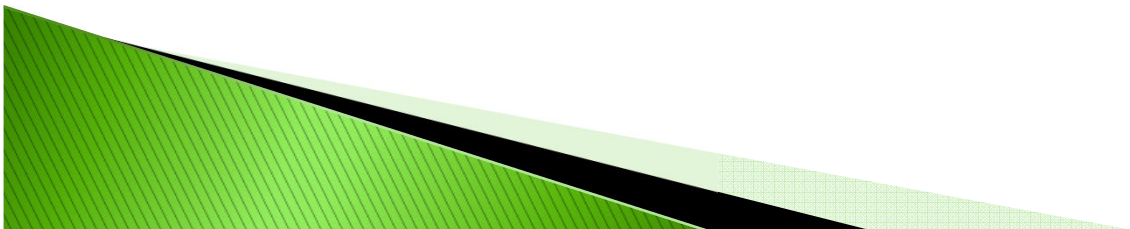

Human Rights Council

► Tasks:

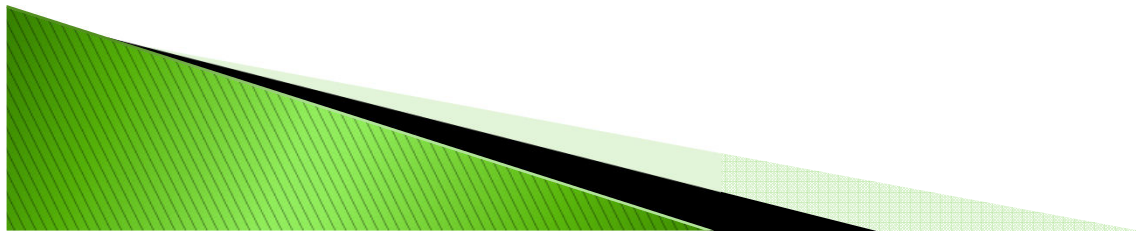
- Protect human rights
- Promote promotion and implementation of human rights
- To develop new concepts and politics
- Standard setting at international and national level
- To protect and avoid human rights violations
- Coordination of human rights work at UN
- Follow up and implementation



Human Rights Council

► Structure

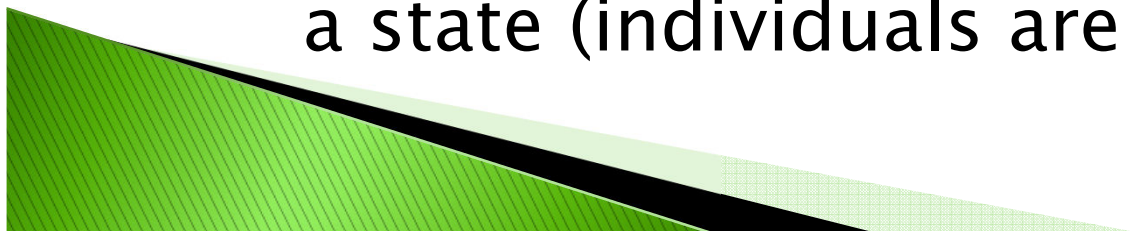
- 47 States
 - 13 Asia
 - 13 Africa
 - 8 Latin– America
 - 7 West Europe and others
- 3 years periods prolongable once



Human Rights Council

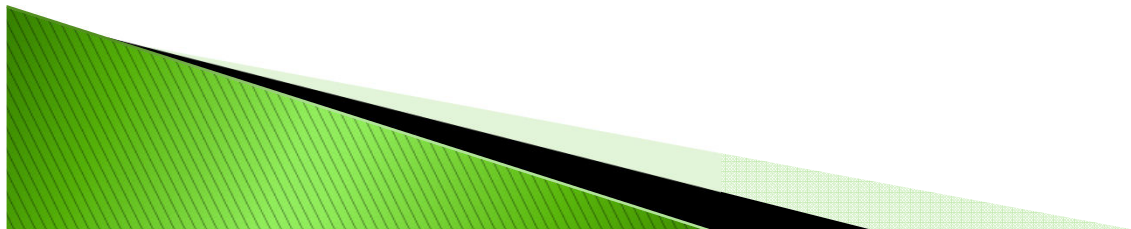
► Instruments

- Universal Periodic Review: peer review
- Special procedures
 - Individual persons or groups
 - Expertise
 - Report to HRC and eventually GA on topic or country (1 a year)
- Complaint procedures
 - Identification of systematic violations by a state (individuals are not the plaintiffs)



Human Rights Council – FIAN's work

- ▶ Human Rights Council Ordinary Sessions
 - Written statements
 - Oral Statements
 - Side Events
 - Opening space for national CSO and communities
 - Lobby work
- ▶ Universal Periodic Review
 - Written submissions
 - Bilateral lobby
 - FIAN SCC?

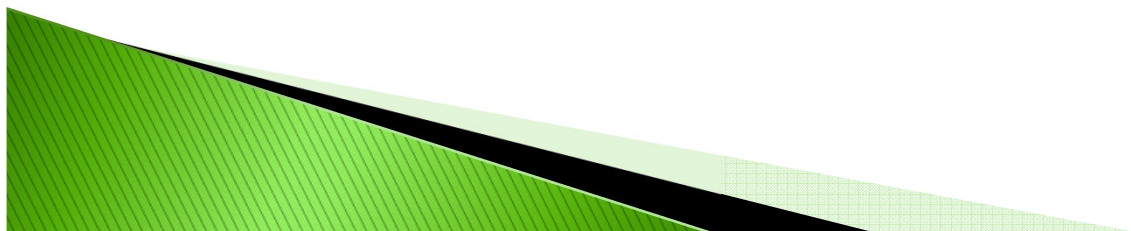

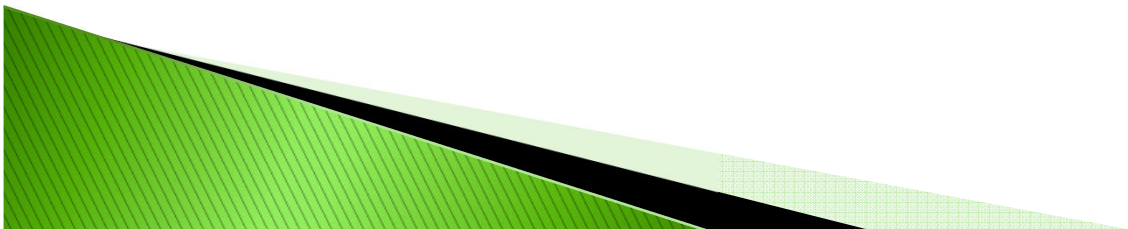
Office of the High Commissioner

► Mandate

To promote and protect the enjoyment and full realization, by all people, of all rights established in the Charter of the United Nations and in international human rights laws and treaties.

► Structure

- Diverse offices and divisions coordinating the HRC. Example: Treaty Body secretariats, petitions unit, division on ESCR, country desks, civil society division.



OHCHR – FIAN's work

- ▶ Division on ESCR
- ▶ Responsible person for the Right to Food
- ▶ SR Team
- ▶ Country officers

Petitions Unit



Committee on Food Security

- ▶ Multi-stakeholders body
- ▶ Food Governance: deciding on concrete actions to address issues affecting food security and nutrition
- ▶ Members: FAO, IFAD, WFP. Other UN state members than FAO members
- ▶ Participants: representatives of UN agencies and bodies, civil society and non-governmental organizations and their networks, international agricultural research systems, IFIs and representatives of private sector associations and private philanthropic foundations



FIAN's Work at CSF

- ▶ General work on renewal: facilitating CS participation
- ▶ Voluntary Guidelines on Responsible Tenure of Land, Fisheries and Forests
- ▶ Global Strategic Framework
- ▶ Civil Society Mechanism

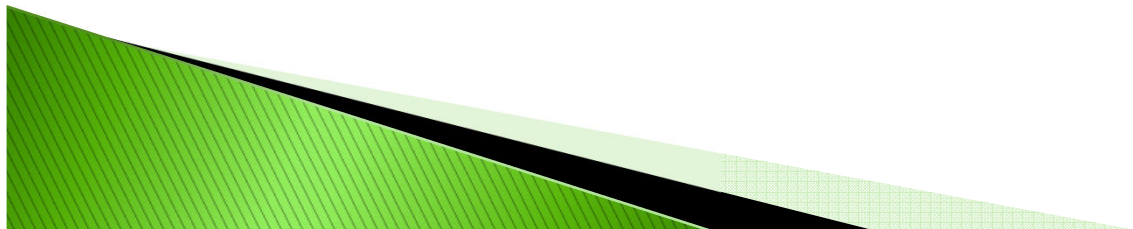
Trough:
